The GRICUA Board is excited to announce the hiring of Mr. Kenneth "Ker

Mr. Stock is a visionary, service and results-focused executive with over two decades of energy and utility experience. Mr. Stock has more than 25 years of engineering, operations, and leadership experience where he has

held positions of increasing responsibility. Mr. Stock most recently served as Assistant City Manager Utility Operations for the City of Albany, Georgia, where he

was responsible for electric, natural gas, water, wastewater, and broadband internet utilities as well as City engineering and Public Works. He also served many years as Vice President of Operations at Kenergy, a large electric distribution cooperative in western Kentucky.

Mr. Stock has effectively led over \$2 billion in capital projects that include wind and solar renewable energy projects, combustion power generation, clean air projects, AMI systems, Enterprise Resource Programs, SCADA and outage management systems, fiber networks, and transmission, distribution, and substation construction.

Purchase Power Adjustment

Over the past year, natural gas and purchased power prices have been extremely volatile and rose dramatically. GRICUA's Purchase Power Adjustment component on customer bills can be used to recover unexpected changes in the cost of purchased power. During this unprecedented time, the GRICUA Board monitored the changes in the cost of purchased power and chose to delay making changes during 2021 to the Purchase Power Adjustment. Unfortunately, the GRICUA Board is no longer able to delay the need to increase the Purchase Power Adjustment. Similar to APS and SRP



increasing their purchase power adjusters in November, GRICUA needs to increase its Purchase Power Adjustment. Currently, GRICUA's rates are under recovering the cost of natural gas and purchased power by \$0.00894 kWh or less than a penny per kWh. Beginning February 1, 2022, the Purchase Power Adjustment will be changed to recover 30% of the \$0.00894 kWh or \$0.00268 kWh. GRICUA will continue to evaluate the cost of natural gas and purchased power going forward and will adjust accordingly. This initial change will increase a typical residential customer's bill by 2.3% or \$3.96 per month, which is again similar to the average monthly increase to residential customers of APS (\$4.00 per month) and SRP (\$3.96 per month).
