AVAILABILITY:

This rate is available at all points where facilities of adequate capacity and the required phase and suitable voltage are available within the vicinity of the lighting installation.

APPLICATION:

To GRICUA owned and maintained unmetered electric lighting controlled by a photo cell device. Includes lighting" for roadways ("street lighting") and ,lighting for public parking lots, public thoroughfares, walkways, and residential yards ("dust-to-dawn" lighting).

TYPE OF SERVICE

Sixty hertz alternating current, three-phase or single-phase, at GRICUA's standard voltages

CONDITIONS:

- 1. For billing purposes, the monthly energy consumption of streetlights and related devices is currently un-metered and estimated by GRICUA, based on wattage per luminaire and device. Estimated monthly consumption of energy is subject to revision by GRICUA, and GRICUA reserves the right to require metering at all installations
- 2. Standard Monthly Equipment Charges are included in the rates below.
- 3. GRICUA will use the most efficient bulb type for new and replacement installations. Mercury vapor and high pressure sodium lighting is no longer available for new or replacement installations.
- 4. Monthly bills will not be reduced because of lamp outages or temporary turnoffs.
- 5. In addition to the charges in this rate, the customer will be responsible for paying GRICUA for any line extensions and/or equipment required to provide service.
- 6. Relocation of GRICUA owned facilities will be done at cost to the requesting party when agreeable to GRICUA.
- 7. No attachments, additions or alterations to GRICUA owned equipment is permitted without the written authorization of GRICUA. If a customer fails to obtain GRICUA's written authorization, GRICUA may i) remove all equipment or ii) back bill for connection fees and energy charges from the initial date of

operation and, at GRICUA's option, add an assessment of an additional fee of \$150 for each un-metered facility or device not reported or other amounts as allowed in GRICUA's Rules and Regulations

- 8. Additions to or conditions relating to the street lighting system other than those contained herein will be by supplemental agreement between the customer and GRICUA.
- 9. Items for which no equipment charge has been included in the Equipment Charge section below (or applicable riders) will be billed at a charge determined by GRICUA.
- 10. Availability of equipment may vary.
- 11. For non-residential customers requesting the installation of street lighting or dusk-to-dawn lighting, a written agreement will be required. The agreement will include the design, cost of installation and specify the equipment to be charged for on a monthly basis. Upon execution of the agreement, a payment in the form of a contribution in aid of construction (CIAC) for the total cost of installation will be due. No construction will begin until the CIAC payment has been received. The initial term of the contract shall be for 10 years. A non-residential customer may cancel a lighting contract and have the equipment removed by paying the Minimum Bill less Energy Charge and Power Purchase Adjustment including applicable tax adjustment, multiplied by the number of remaining months of the agreement, or by paying the straight line depreciated cost of GRICUA's initial installation and current removal costs of the light fixtures and associated facilities, whichever is lower.
- 12. For residential customers requesting the installation of dusk-to-dawn lighting, a written agreement will be required. The agreement will include the design, cost of installation and specify the equipment to be charged on a monthly basis. Upon execution of the agreement, a payment in the form of a reduced contribution in aid of construction (CIAC) for the total cost of installation will be due. No construction will begin until the CIAC payment has been received. The initial term of the contract shall be for 10 years. A residential customer may cancel a lighting contract and have the equipment removed by paying the Minimum Bill less Energy Charge and Power Purchase Adjustment including applicable tax adjustment, multiplied by the number of remaining months of the agreement, or by paying the straight line depreciated cost of GRICUA's initial installation and

current removal costs of the light fixtures and associated facilities, whichever is lower.

MINIMUM BILL

The greater of:

- 1. The Monthly Service Charge (if any), Equipment Charges, Purchase Power Adjustment and the Energy Charge per luminaire, or
- 2. A minimum monthly dollar amount specified in a written Agreement for Electric Service, if any.

ADJUSTMENTS

- 1. GRICUA may increase or decrease billings under this schedule in proportion to any taxes, fees, or charges levied or imposed by any governmental authority and payable by GRICUA for any services, power, or energy provided under this schedule.
- 2. GRICUA may increase or decrease billings under this schedule in proportion to any changes to the Monthly Fee; Energy, Delivery, and System Charges; and/or Purchased Power Adjustment under this schedule.
- 3. GRICUA may increase or decrease the price of Purchased Power Adjustment based on changes in the cost of purchased power.

RULES AND REGULATIONS:

Service under this schedule is provided in accordance with the Rules & Regulations for Service established by the Gila River Indian Community Utility Authority.

RESIDENTIAL DUSK-TO-DAWN INSTALLATION COST

The Installation Cost will be a one-time payment as listed below and due upon the signing of the agreement for service.
